

HELP DOCUMENT FOR APPLICANT

KSTIM & PUBLIC WORKS DEPARTMENT

Apply online for Right of Way Permissions & Road Cutting permissions

Based on the directions contained in the Government order G.O.(Ms)No.25/2018/ITD Dated 11/10/2018, Kerala State IT Mission have developed a new online portal for granting Right of Way (RoW) permissions to Telecom Service Providers(TSPs)/Infrastructure Providers(IPs) for laying Optical Fiber Cables(OFCs), road cutting permissions for laying pipelines etc along the road networks in Kerala. This portal is now available in the web site link https://rowservices.kerala.gov.in/.

The Telecom companies (TSP) are applying for Rights of Way permissions for laying underground cables across the state. The applications along with the route map, distance and other supporting documents were submitted to the Electronics & IT Department of the State for getting the single window clearance. The applications were examined by the Committee of Secretaries and approval accorded. Thereafter the G.O will be issued by the IT Department after collecting the bank guarantee and the one time contribution. The TSP has to approach the concerned road authority / local bodies for getting the permission for road cutting.

This portal includes facilities for onetime registration of TSPs, application preparation and submission, verification by IT department & Kerala State IT Mission and approval of road cuttings by Road authority.

This online portal is having controlled access so that, only authorized users can use the system. Every Telecom Service Provider / Internet Service Provider / Infrastructure Provider needs to contact Kerala State IT Mission for obtaining user credentials. After approval, the user credentials will be given through e-mail. There are two types of login provided one is as applicant and the other is as official. Those who want to submit the applications for RoW permissions or road cutting permissions shall have user credentials as applicant. Those who are processing and giving approvals for applications shall have official type user credentials.

Password can be changed using **Reset Password** option after logged in. Each Super User can create sub users under their Organization. Sub users will get login credentials after getting approval from KSITM. Application submission of RoW permission by Telecom Service Providers

1) Visit <u>https://rowservices.kerala.gov.in/</u> and the login page will displayed. Click the Applicant button and give the username and password(Given by IT Mission). After typing username and password click the LOGIN button.

Applicant can submit any number of stretches against all road authorities through single application.

Additional stretches can be added by clicking the plus button on the right side of listing. It is important to note that the department having authority of the stretch should be correctly chosen. Once submitted, the application cannot be edited.

Here the details of application can be edited by clicking the edit icon with the list items. There is provision for uploading the GIS map of stretches and the Government Order (from ITD / PWD) for the selected stretches. For this select the appropriate GO type from the dropdown list and then upload the GO copy in pdf. The user can also add new stretches by clicking the Add New Stretch button at the bottom area. After all these, click the submit button for generating the application reference number.



Here select the road stretch to be applied and then click the Apply button for the final submission. After this final submission only, the application will be forwarded to the concerned Road Authority.

After the final submission, the current status of the application can be tracked from the left side menu "Applied Stretch Status".

Once the application is submitted to the Road Authority selected, then the application shall be processed by the concerned road authority. The following actions will be taken and intimated to the applicant through the online system

- 1) If the application is not in order or incomplete, the application will be returned/reverted for correction
- 2) If the permission cannot be issued or denied then the application will be returned
- 3) If demand note for restoration charges is approved by the authority then the application will be given for depositing restoration charges and BG submission
- 4) Once, the restoration charges and BG is submitted by the applicant, then the Road Authority will process the application and cutting permission will be issued
- 5) If there is any clarification of the restoration charges/BG is required by the Road Authority then the application will be reverted for payment clarification
- 6) In case of RoW permissions, after the road cutting permission is received and completed the work, the applicant need to notify the Road Authority regarding the completion of work and request for NOC
- 7) If the Road Authority satisfies that the work is completed as per the conditions laid down in the permission letter, then NOC will be issued, otherwise revert back the application for work completion

The applicant can view the status of application and do the processing in their Inbox section which is available in the left side menus.
